### YOU ARE NO LONGER REGISTERED AND CANNOT PRACTISE AS A DENTAL PRACTITIONER IN QUEENSLAND.

As your completed renewal form and fee were not received at this office, or you did not renew registration online by 30 June 2009, your registration has expired. It is a breach of the *Dental Practitioners Registration Act 2001* for you to continue to practise in Queensland.

If you wish to resume practice in Queensland, **you must restore your registration on or before 30 September 2009.**

**You cannot practise until restoration is approved.**

You are not required to return this form if you do not intend to practise in Queensland. **To restore** your registration you must read, complete and return this form with the prescribed payment amount in the enclosed envelope, to be received at this office no later than 30 September 2009.

#### Restoration is effective:

- from the date the restoration is approved and cannot be backdated; and
- to the last day of the current registration period (that is, 30 June 2010).

Select the register, enter your last name (first name optional), select Search and, from search results, select your name to view details, including registration status.

**After 30 September 2009 the Act does not provide the Board with discretion to restore registration. If you wish to resume practice in Queensland after this date:**

- you will need to make a fresh application to the Board for registration; and
- if you do not have a qualification prescribed under the *Dental Practitioners Registration Regulation 2001* you may no longer be qualified for registration in Queensland (a link to online legislation is available on the Board's website).

### IMPORTANT:

If your registration is restored, you must notify the Board if you are affected by any of the following:

- a. a change in your name (notification is required within 21 days and documentary evidence such as a **certified copy** of a marriage certificate must be supplied);
- b. a change in your address (notification is required within 21 days - this excludes a change of email address, which, while not required, would be appreciated);
- c. the withdrawal or cancellation of your qualification for registration (notification is required within 21 days);
- d. conviction for an indictable offence in Queensland or under a corresponding law (notification is required within 30 days);
- e. delivery of a judgement or settlement of proceedings if you are a party to proceedings in court claiming damages or compensation for alleged negligence by you or in the practice of your profession (notification is required within 30 days); OR
- f. cancellation, suspension, or application of a condition, undertaking or other disciplinary action to registration, licence or certification you hold under a corresponding law (notification is required within 30 days).
